Sub-Decree No. 110 on Granting an Authorization for the Operations of Information & Telecommunication Technology

Sub-Decree No. 110 on Granting an Authorization for the Operations of Information & Telecommunication Technology ("Sub-Decree") was issued by the Ministry of Post & Telecommunications ("MPTC") in July 21, 2017. Remarkably, among other purposes, this Sub-Degree aims to ensure an effective management of Information Communication Technology ("ICT") industry, and is specifically applicable for all businesses operating in ICT sector in Cambodia.

I. Categorization

Under this Sub-Decree, the approval is classified into 03 (three) categories: Authorization Letter, Certificate, and License. Each type of approval is required depending on the business activities which the applicant operates.

II. Reporting Requirement

Every ICT operator has an obligation to submit the document on the original cost management, independent audited financial report and non-financial information every fiscal year within 90 (ninety) days to MPTC. In the event of failure to submit the said documents, transactional fine between 20,000,000 (twenty million) Riels to 60,000,000 (sixty million) Riels will be imposed on any ICT operators who did not comply with the requirement.

III. <u>Business Transfer and Cessation</u>

Transferring the authorization letter, certificate, or license to a third party by way of an agreement, succession or company merger shall be done in accordance with the regulation under this Sub-Decree and other existing regulations.

In the event that ICT operator or ICT related individual intends to cease their operation, ICT operator or ICT related individual shall give at least 30 (thirty) days prior notice in writing to GDICT or Provincial Department of Posts and Telecommunication of MPTC, together with particular reasons to explain their intention for the business cessation. In that case, MPTC will request ICT operator or ICT related individual to satisfy one or more requirement(s) before ceasing their operation.

IV. Penalty

Transactional monetary fine, in accordance with the Sub-Decree and determined by MPTC's Prakas, will be imposed on any individual who conduct the business without an approval from GDICT or Provincial Department of Posts and Telecommunication of MPTC. A failure to pay the said penalty within 30 (thirty) days from the date of the receipt of the decision, MPTC shall refer the matter to the prosecution office of the Court of First Instance.
